New Software Updates Improve Practice Efficiency for Medical Practitioners and Provides Enhanced Convenience to Achieve Patient Satisfaction

This new feature simplifies group therapy session documentation.

The ePayments feature also integrates with the Payment Planning Module, enabling the practice to automatically bill credit cards that are on file, as well as gives practices the ability to set up a credit card payment plan for patients who have outstanding charges, or create a plan for a specific recurring dollar amount.
